# **Position Description**



## **Position Summary:**

This position is responsible for supporting and administering medicines procurement strategy and inventory management systems to ensure safe, rational and cost-effective use of medicines and medicinal products at Eye and Ear.

This position also has an operational role in ensuring effective, efficient and personalised pharmacy service to the highest ethical, legal and professional standards within hospital policies and legal requirements.

### **Key Responsibilities / Performance Outcomes:**

- 1. Provide high quality standards of patient care. This includes assessment, planning, implementation and evaluation of care in collaboration with patients, carers and a multidisciplinary team.
- 2. Work within an ethically and legally sound framework. Ensure that the delivery of clinical services within the Department is in line with best evidence based practice, the Eye and Ear policies and procedures, applicable legislation, and the National Safety and Quality Health Service Standards (NSQHSS).
- 3. Information Technology (IT) skills that are commensurate with the requirements of the role.
- 4. Medicines Evaluation & Procurement
- Contribute to the development and delivery of the hospital procurement plan for best monetary value
- Ensure continuity of supply of medicines and medicinal products for patient care including medicine/product evaluation and formulation of procurement action plan
- Ensure procurement plans meet the clinical needs and are within the financial target and budget
- Assist in identifying and implementing medicines expenditure minimisation activities
- Actively monitor and report on pharmacy product and supply functions (financial, operations and quality)
- Oversee the planning and co-ordination of the hospital imprest management
- Oversee regular imprest and pharmacy stock reviews to optimise stockholding and stockturn
- Ensure drug recalls are managed appropriately
- Assist with contract and vendor management
- Ensure procurement activities are in compliance with Health Share Victroia Collective Agreement
- Conduct usage evaluation and promote quality use of medicines
- Oversee and administer the Medicines Access Programs

- System administrator for Omnicell Automated Dispensing Cabinets and Merlin Pharmacy System
- Maintain and utilise the inventory systems effectively to optimise stock management and reporting
- Monitor and report anomalies in stock transactions

#### 6. Dispensary Support

- Supply medicines and medical products to customers/clients of the Eye and Ear according
  to Eye and Ear policies and procedures. This includes but not limited to dispensing,
  compounding (simple and complex) and private sales.
- Provide information on medicines and medical products to clients and staff of the Ear and Ear.
- Provide support to pharmacy staff in dispensary and manufacturing areas.

#### 7. Clinical support

- Provide high quality clinical pharmacy services aligning with current professional standards.
- Provide clinical interpretation of medication related matters.
- Assist in developing, reviewing, updating and implementing policies and procedures.
- Assist in quality improvement projects
- Provide medicines information to patients and health professionals

#### 8. Education and training

- Participate in orientation and training of all new staff members.
- Participate in the pharmacy department professional development program.
- Provide training on (Victorian Health Incident Monitoring System) VHIMS/RiskMan incident reporting to all new pharmacy staff members.
- Participate in education and training to other clinical groups (within the hospital) as required.
- Act as a point of reference for pharmacy, nursing and medical staff in aspects of medication safety and quality use of medicines.
- Organise and distribute material using a variety of mediums to inform and educate the wider hospital audience on progress of various projects and medication safety initiatives.

#### 9. Research and development

- Participate and/or contribute to research as required.
- Participate and/or contribute to conference/external presentations and publications.

#### 10. Other

- Participate in staggered shift, oncall, weekend and public holiday pharmacy services as rostered.
- Attend and actively contribute to pharmacy department meetings and educational forums.
- Represent the pharmacy at internal and external meetings.



### **Quality, Patient Safety And Risk Management**

Ensure utilisation of systems designed to support quality, safety & risk management. This involves:

- Providing care that is patient and family-centred and delivered in partnership with the patient and their carer.
- Developing and maintaining your skills and competencies relevant to your clinical scope of practice.
- Having an understanding of working within your role and responsibilities outlined in the Eye and Ear Quality Clinical Governance Framework to deliver safe high quality and person-centred experience and care.
- Participating in reporting and analysis of safety and quality data including risks or hazards.
- Participating in improvement activities.
- Participating in the reporting and analysis of quality initiatives, adverse events and risk identification.
- Participating in appropriate professional development activities and other quality and safety training.
- Participating in health service activities required for accreditation.
- Ensuring appropriate use of hospital resources.
- Working within and ensuring staff are compliant with the Eye and Ear Data Accountability Framework.

## **Occupational Health And Safety**

The Eye and Ear endeavours to provide a working environment for its employees that is safe and without risk to health. Employees are required to:

- Perform their work with due regard for their own safety and health and for the safety and health of other people who may be affected by their acts or omissions.
