The Eye and Ear provides care annually for around 250,000 patients, with over 200,000 outpatients, nearly 40,000 emergency patients and over 14,000 inpatients.

Position Summary:

The Fellow attends 2 Ocular Immunology Clinics and 2 Medical Retina clinics per week. Attendance at other clinics may be requested by the Head of the Ocular Immunology Unit.

The Fellow will also staff 2 dedicated Ocular Immunology Surgery (cataract) lists per month as the Primary Surgeon, and is expected to operate unsupervised for some of these lists. The Fellow will also have substantial exposure to digital angiography, OCT and intravitreal injections.

The Fellow is involved with research and ongoing studies from the Macular Research Unit and the Uveitis and Retinal Vascular Research Unit at CERA.

Fellowship includes staffing an AOS clinic once a month, with the opportunity to observe clinics at the RCH to gain exposure in paediatric uveitis.

On call duties will be 1 in 2 weeks, for patients of the Ocular Immunology and Medical Retina Units (and their consultants).

Participation in the Emergency Medicine roster with hours ranging from 0745 to 2200 and Saturday or Sunday shifts as rostered is negotiable.

Fellows are expected to contribute to the education and professional development of junior registrars by providing regular teaching, supervision, and clinical guidance within the department.

Key Responsibilities / Performance Outcomes:

1. Provide high quality standards of patient care. This includes assessment, planning, implementation and evaluation of care in collaboration with patients, carers and a multidisciplinary team.
2. Work within an ethically and legally sound framework. Ensure that the delivery of clinical services within the Department is in line with best evidence based practice and the National Safety and Quality Health Service Standards (NSQHSS).
3. Information Technology (IT) skills that are commensurate with the requirements of the role.
4. Provision of on-call service as rostered for patients of the Ocular Immunology and Medical Retina Units and their consultants is required.
5. To participate in research under the direction of the Head of the Ocular Immunology Unit. Research hours may be noted on the roster but not paid by the Hospital, except where alternative funding arrangements have been secured i.e. The Hospital Ethics & Research Committee or other research grants.
6. The effective teaching and supervision of junior medical staff in the Ocular Immunology Clinic.

Quality, Patient Safety And Risk Management

Ensure utilisation of systems designed to support quality, safety & risk management. This involves:

- Providing care that is patient and family-centred and delivered in partnership with the patient and their carer.
- Developing and maintaining your skills and competencies relevant to your clinical scope of practice.

- Participating in health service activities required for accreditation.
- Ensuring appropriate use of hospital resources.
- Demonstrate awareness of the financial requirements of the department and demonstrate an awareness of cost effective practice.
- Actively participate in the annual performance development cycle.

Occupational Health And Safety

The Eye and Ear endeavours to provide a working environment for its employees that is safe and without risk to health. Employees are required to:

- Perform their work with due regard for their own safety and health and for the safety and health of other people who may be affected by their acts or omissions.
- Actively promote and demonstrate the organisational values of integrity, care, excellence and teamwork.
- Participate in wellness@work initiatives.

- Actively discourage and where possible call out inappropriate behaviour that may pose a safety risk to others.
- Participate actively in return to work programs if injured, and supporting injured colleagues in their return to work.
- All clinical practitioners involved in medication management have an obligation to practice within legislation, the Poisons Control Plan, hospital policy and procedures.
- The requirement for Advance Life Support training will be determined for nursing and medical staff working in specific departments based on acuity.
